# Consistent financial reporting framework: 2018 to 2019

For Kent and Medway Schools, the new 18/19 Consistent Financial Reporting (CFR) guidance is now online.

All Private Finance Initiative (PFI) schools will now need to record their expenditure against E28b if it relates to their PFI agreement.

All other E28 expenditure (and for any Kent schools who are not subject to a PFI agreement) should continue to be coded to the E28 code as normal.

There is no need to set up a new E28a code on your accounting system or financial planning tool.
