Department for Education, Early Years Professional Development Fund

In October 2018, Kent was invited by the Department for Education (DfE) to be one of 54 local authorities to take part in the Early Years Professional Development Fund (EYPDF). Over a three year period (2019 – 2022) this fund will train a network of Continuous Professional Development (CPD) 'Champions' who in turn will lead and cascade professional development activity through newly established early years CPD partnerships in their local area.

The DfE will directly grant fund local authorities to:

- convene local early years CPD partnerships identifying and recruiting prereception Private, Voluntary and Independent settings and schools, attended by disadvantaged children, to participate in collaborative CPD activity
- nominate suitably skilled and experienced local pre-reception practitioners as 'CPD Champions' who will receive training from a national Delivery Partner and then cascade to other practitioners via their CPD partnerships
- manage the CPD cascade model developing local delivery plans to manage the cascaded CPD activity and administering funds from DfE to cover local staff backfill costs so the training is free for practitioners to attend, which will account for the vast majority of expenditure.

We received confirmation recently that Kent will be funded for four CPD Partnerships. In Kent, The Education People will lead and manage the EYPDF on behalf of KCC. More information will follow in due course about where (in the context of DfE criteria) these partnerships will be. Look out for this information in the next and subsequent bulletins and at the June Early Years and Childcare Briefing and Networking Sessions (please see page 9 for details of dates and venues).

Tax-Free Childcare

If you have parents who are struggling to meet the cost of their childcare or want to buy additional hours outside of their free entitlements please direct them to https://www.childcarechoices.gov.uk/ to check whether they are eligible to register for Tax-Free Childcare.

How will this benefit you?

Tax-Free Childcare is a UK wide offer. Eligible parents with children under 12 can get up to £2,000 per child, per year, towards their childcare costs (or up to £4,000 for disabled children under 17). For example, a parent paying £8,000 into their tax-free childcare account per annum will have a further £2,000 added by the government per annum to pay for childcare.

Parents entering the scheme open an online childcare account which they use to pay you directly for childcare. Payments work just as they do through an online bank account. Each payment is accompanied by a reference number for each child so you can identify their payments.

You will only be able to receive Tax-Free Childcare payments from your families if you've signed up to Tax-Free Childcare.

Over time, Tax-Free Childcare will replace childcare vouchers. By signing up now, you'll be ready to accept payments from parents as soon as they ask to pay using Tax-Free Childcare.

Signing up to Tax-Free Childcare does not affect any payments you receive through childcare voucher schemes.

If you're an approved or registered childcare provider, you can sign up to get a childcare provider account. This allows you to set up your bank account details and receive payments from parents who use Tax-Free Childcare.

Early Education and Childcare Funding Reminders

Estimate collection for the autumn terms one and two will be Friday 28 June – Tuesday 9 July 2019. Please ensure you check your numbers so that it is the total hours for all children per **week** input in to the box, this will then calculate the total hours per term.

The 30 Hour Audit of Codes will be sent to providers by Friday 31 May. The midterm 30 Hour Audit is based on your summer term headcount claim and will highlight those children who will be eligible in the autumn terms and which children will enter their grace period before the start of term. This is an opportunity for you to speak to the parents to encourage them to renew their details with HMRC in time for their code to be updated for an autumn term claim.

Childminders

Recently published childminder Ofsted reports have shown some trends in actions and recommendations. These cover specific areas that you may wish to use as a means of self-evaluation for your own setting and practice.

For those not yet good these have included:

- Improved risk assessment to keep children safe
- Provision of an enabling environment
- Information sharing with parents and support to parents in helping children to make even better progress at home. Partnership working with other settings and agencies
- Better use of professional development opportunities to keep up to date with changes in legislation.

For those wishing to be outstanding these have included:

- Strengthening partnership working with parents and staff at other settings that children attend in order to create greater continuity to help them make even more progress
- Enhancing opportunities to develop children's communication and language, markmaking technology and mathematical skills
- Developing children's respect and understanding of other people's similarities and differences outside of their own communities and religious beliefs more extensively
- Better use of professional development opportunities to enhance knowledge and skills, to help raise the quality of teaching to a higher level.

Below are some key points to consider:

The Childminding Environment

The environment you create needs to continue to meet the needs of the ages and abilities of the children you are currently caring for. It should provide a safe but stimulating space that enables children to explore confidently and make independent choices in their play that enable them to follow their individual interests. There also needs to be an available space for children to relax and switch off as required. Sufficient resources should be accessible which allow children to explore all areas of learning and provide opportunities that will enable them to practise their early reading, writing and mathematical skills. Children's imagination and creativity can be promoted by offering open-ended resources – materials that have a multitude of uses help children be curious and experimental. Many plastic toys have limited learning outcomes so loose parts and natural resources give children wider opportunities to extend learning. The outside space is also where children enjoy learning, this offers many opportunities for children to learn about the natural world as well as them developing their physical skills.

Partnerships with families

It is recognised that when childcare providers and parents work closely together then children make even better progress. Parents are required to be kept informed about their child's achievements and encouraged to support the learning further at home. Regular two-way sharing of information promotes consistency and continuity for the child that they can consolidate their knowledge to help them build a deeper level of understanding. Simple activity ideas can be provided to parents based around the child's next steps, these can then be carried out at home and the parent can feedback information around the learning that took place. The challenge for many childminders is to ensure that this is happening with every parent as some are more willing than others. Using different strategies may be necessary to encourage the more reluctant parent to participate.

Working with other settings

When children attend another setting it is important to seek parental permission to be able to communicate with the child's key person. Therefore, key information regarding current interests, abilities and next steps can be shared that will promote learning in both settings and create a united approach. This coordinated way of working will effectively support the child's learning and overall progress.

DBS

DBS checks must be undertaken for any assistants that are working in the childminding setting. Ofsted need to be informed of the arrangement and the assistant must be approved as a suitable person to work with young children. DBS checks are also needed for new partners or anyone moving into the premises.
