Benchmarking

Benchmarking is the process of comparing your school's spending with similar schools and schools with similar challenges. It allows your school to look at spend in different areas such as staffing, supplies and services, buildings and land, as well as against the individual Consistent Financial Reporting (CFR) codes. It helps you inform your school development process.

Benchmarking helps you to consider how to use your resources to support high-quality teaching and the best education outcomes for your pupils.

Benchmarking helps you to connect with other schools to discuss challenges and successes. This can help you consider whether:

- your resource allocations are working for you
- you can improve outcomes by doing things differently

Benchmarking is only a guide. Some schools may find themselves at the lower or upper extremes of the data. You should consider local knowledge about your school when assessing the data.

This benchmarking report includes actual income and expenditure data up to the 2018/19 financial year and estimated data for 2019/20.

Data is shown in two different ways:

- A pie chart with 2018/19 actuals for your school
- A line chart with analysis of previous years and an estimated forecast based on your three year plan submission. The line chart compares to the 5 similar schools and all Kent Primary schools.

Expenditure

Things to Consider

Staffing - E01, E03, E04, E05, E06, E07

Costs may vary between schools depending whether a school employs their own staff or buys in a professional service instead which would be assigned to an alternative code (e.g. one school may employ a groundsman coding to E04 whereas another may purchase a grounds maintenance contract which would be coded to E14). Likewise a school may have higher admin costs as they undertake finance in house whereas another school purchases a service to undertake this work which would be coded to E28.

It would also be prudent to consider whether another school which has higher staffing expenditure has higher levels of income on codes such as I06,I07 and I08 as this may indicate they are employing staff on fixed contracts due to grants received or self generated income for services offered.

E03 may be higher costs if the school has a higher number of High Needs Pupils with 1:1 teaching assistants

E06 may be higher costs if the school is running their own catering for school meals rather than using a catering company

Supply – E02, E26

Costs will differ depending on how schools pay for their supply cover. If it is in house the costs will be allocated to E02. If they have staff supplied by an agency then this will be allocated to E26 instead. Also consider the level of supply used in conjunction with the costs attributed to the staffing codes (E01, E03-E07). It may be some schools are supporting their staffing structure with supply staff on a long term basis.

Indirect Staff Costs – E08, E09

Kent schools have been advised to allocate their Apprenticeship Levy contributions to E08. However, any Voluntary Aided or Foundation schools will only pay a contribution if they have payrolls of over £3 million per annum.

Consideration should also be made to the make up of the staff at the schools included in the benchmarking. If a school has a lot of new staff (e.g. NQT teachers) it is likely that the training costs may be higher than comparison schools who have more experienced individuals. A lower cost for staffing and a higher budget for indirect staff costs MAY indicate this.

Insurance – E10, E11, E23

Costs will differ depending on what insurance packages schools have applied for as well as what claims they may have processed.

Premises Costs – E12, E13, E14, E18

These should cover day to day maintenance of the school property. However, depending on the size/condition of the property some schools may see higher expenditure compared to others.

E14 may be higher if a school has a cleaning contract rather than employing their own cleaners under E04

Utilities – E15, E16, E17

If a school has additional facilities that other schools selected do not have this can affect the benchmarking. For example, if one of the comparison schools has a swimming pool then the expectation is that their utilities would be higher than other schools for this reason. Also, it may be that some schools within the selection only have electricity or use oil which will impact on the comparison.

Curriculum – E19, E20, E21, E27

If a school organises a lot of trips for pupils, which parents pay for, the expenditure will be assigned to E19 and may appear higher compared to other schools. However, consideration should be given to what they are receiving in income (against I12) as this may also be higher and offset the expenditure.

Also, depending on how schools are spending their Sports Grant Income (see County Pupil Lead grouping) may also impact on comparisons against E19 and E27 accordingly.

Any expenditure against E21 should only be for secondary schools and as such should not impact on primary schools.

Other - E22, E24, E25, E28, E28B, E29, E30, E31, E32

In E22, additional expenditure may be seen by schools that have experienced a rising roll or have recently made some large purchases (e.g. a large amount of admin furniture etc).

In E28, did the school(s) being compared against have any legal issues which required additional expertise (e.g. disciplinary issues) or do they have additional support (e.g. SPS, Capita or Schools Financial Services etc) as this can impact on the expenditure. Note: for PFI schools, Actuals for prior years have been split out to allow for a more acurate Benchmarking. Forecast figures however haven't been split out so this may have an effect on figures shown.

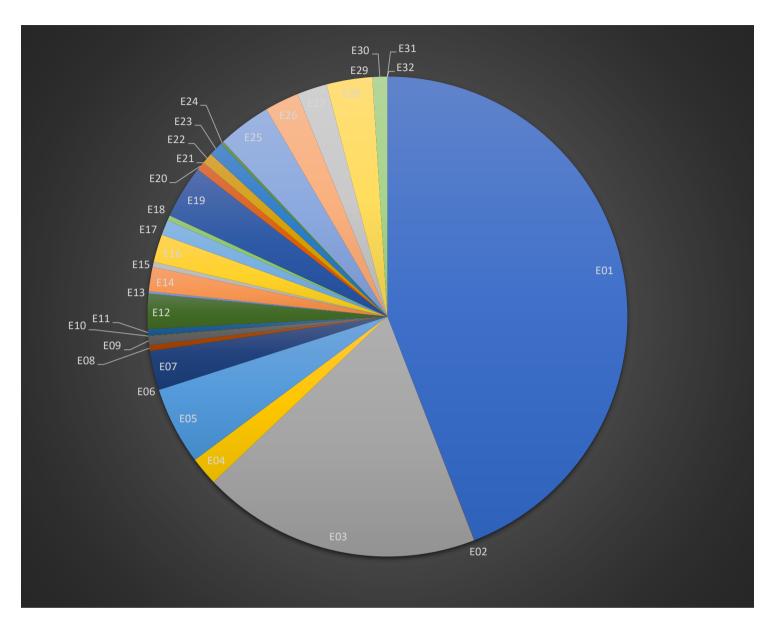
In E25, additional expenditure may be seen by schools that have experienced a rising roll or have recently made some large purchases (e.g. a large amount of catering equipment, deep cleans etc).

Loan interest is also allocated to E29, therefore if a school in the benchmarking comparison has a loan this will affect the figures.

In E30, schools may have made contributions to capital projects . If a large amount has been moved to pay for a capital project in one year this may impact on the comparison between schools as well as financial years.

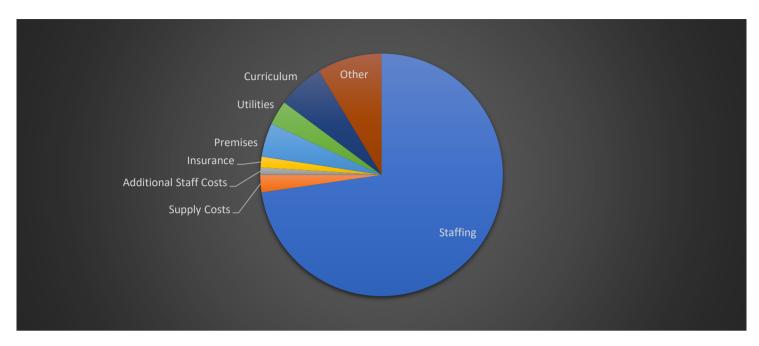
If a school provides additional facilities for the benefit of the community these will be coded to E31 and E32 respectively. If they receive income this would show against I16 and I17.

Premises Costs Split by Ledger Code



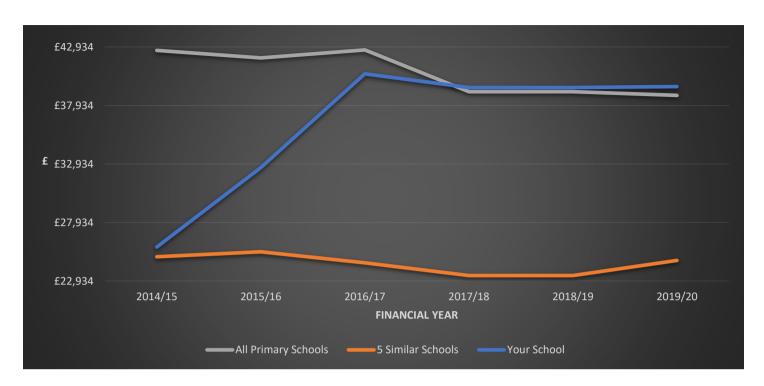

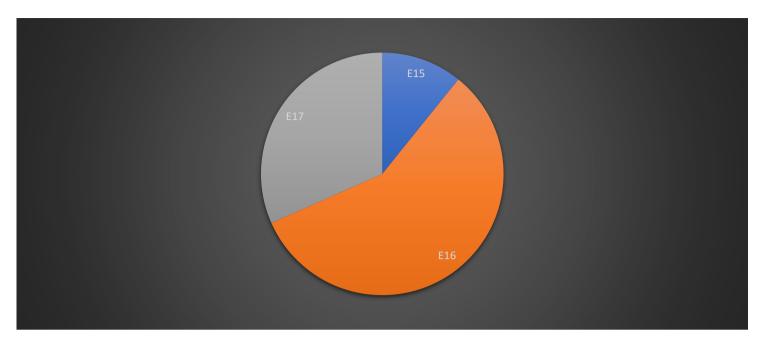

Utilities Costs Split by Ledger Code



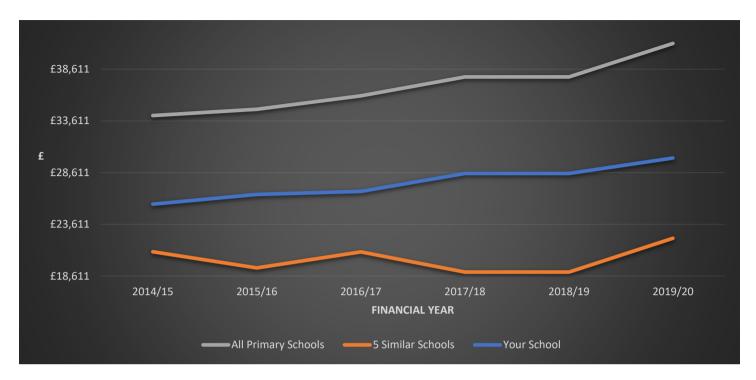

Income

Income - Things to Consider

County Pupil Led - 101, 102, 103, 105, 118

The majority of the funding received (IO1) is based on the number and demographic of pupils at the school.

Schools with Early Years provisions will also receive more funding than those without but the expectation would be that they would see more expenditure as well to cover the services provided.

Schools going through a period of growth will also see higher levels of funding compared to others.

Sixth Form Funding (IO2) would only be received by secondary schools, so all primary schools should not expect to see this funding.

High Needs funding is paid through the IO1 and IO3 codes and is pupil specific. Therefore, a school with a higher number of pupils with additional and complex needs will receive higher levels of funding but would also expect to see increased costs for staffing and learning resources.

Pupil Premium funding (I05) is affected by the demographic of the schools being compared i.e a similar school in a more affluent area may receive less income for Pupil Premium.

Also, this may be higher for schools on or near the county borders as they may also receive income for out of county children compared to those schools that are not.

Universal Infant Free School Meals are funded via the I18 code and as such, schools with infant pupils would see higher income against this code. However, schools may see higher costs against E25 and E07. Also, potentially E06 (if using internal catering).

The Sports Grant is also paid via I18 and is based on a lump sum as well as an amount per pupil. The funding increased significantly in November 2017 and as such primary schools would see higher rates of income in 17/18 onwards.

Grants – 106, 107

This is dependant on the types of grants that have been awarded as well as the applications made by each school.

Any grants received by a school should show the associated spend as well which will result in an increase in expenditure codes (in the same year or the following one).

Facilities, Services & Catering – 108, 108B, 109

Some schools may have more additional streams of income than other comparable schools (e.g. lettings, breakfast/after school clubs). However, they are also likely to also have additional costs as a result

The income from some facilities may also be affected by the pupil roll, a school with an increasing number could see increases in income from other services offered (e.g. breakfast/afterschool club).

109 Consider if the school has in-house catering or uses a catering company as there will be differences in income depending on whether the school is collecting dinner money directly.

Insurance — | 10, | 11

If a school has entered into an employee insurance agreement they may see income against this grouping for absence (e.g. sickness, maternity). However, this is dependent on the number of absences that have occurred and there would normally be an increase in expenditure (staffing, supply etc) to cover the absence.

Donations & Trips – I12, I13

Depending on the number of trips organised by each school as well as how much is paid for by income from parents will dictate how much is allocated to I12.

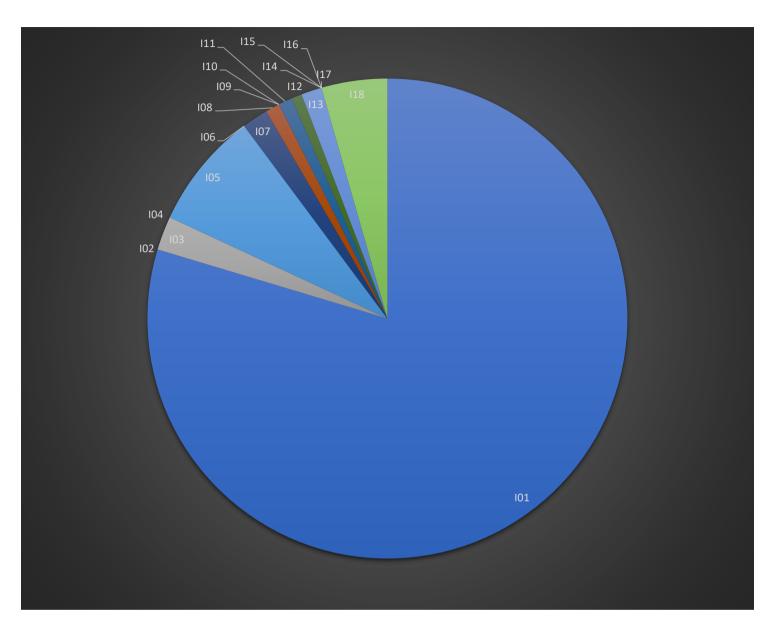
Unless the school is subsidising the trip then the expenditure against E19 should also be higher as a result.

Any donations received can fluctuate between each school and also depend on what the school plans are (e.g. new play equipment is being paid for by a donation) which may be one-offs in a particular year as well as how these are received (e.g. some schools have a separate account – Voluntary Fund for this).

Other – 104, 114, 115, 116, 117

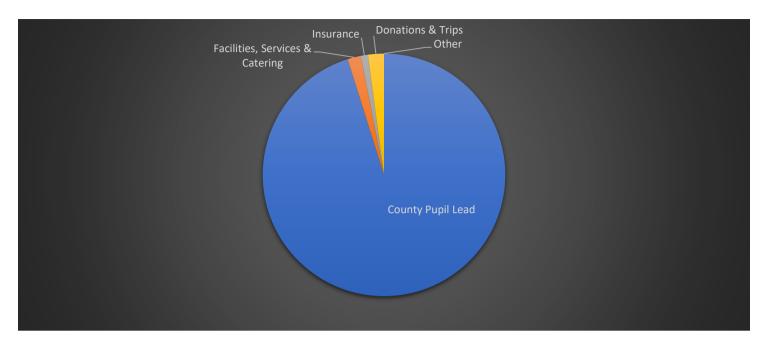

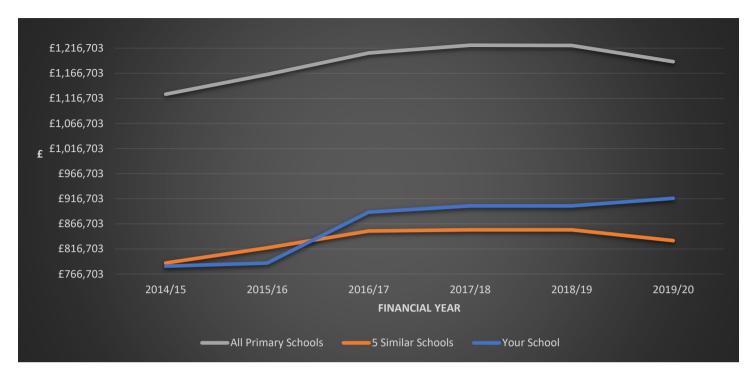
Total Income Split by Category

Donations & Trip Income Split by Ledger Code



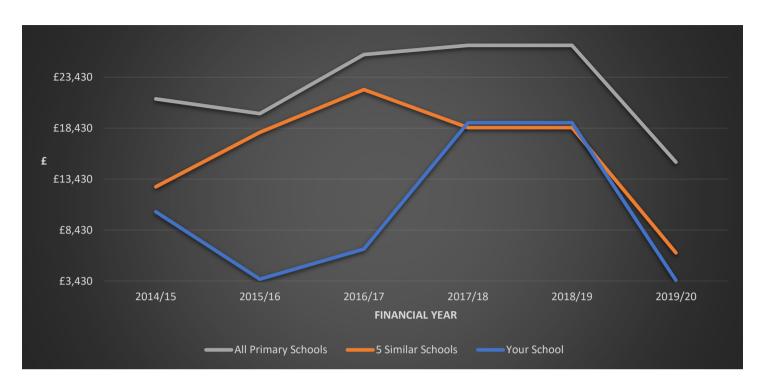
