Department for Education Update

DfE Integrated Curriculum and Financial Planning – Free Webinar – Action Required

Understanding Integrated Curriculum Financial Planning (ICFP) can enhance collaborative and informed decision making by your school's leadership team. <u>These free DfE funded 1- hour training webinars</u> provide a broad understanding of the basics of ICFP; they have been designed specifically for school business professionals, Headteachers and Governors.

School Governance Updates - Action Required

New Year updates from DfE are available for both <u>LA Maintained schools</u> and <u>Academy Trusts</u>, please be sure to <u>register for updates</u> directly to your mailbox; items in this edition include consultation on the removal of the outstanding exemption, NFER/DfE survey, GIAS National Database requirements, compare how much your school is spending on agency supply teachers, Clerks' voices required re The Governance Professional role.

Keeping Children Safe in Education 2019 (KCSIE) - Section 128 checks for governors - Action Required

Your attention is drawn to <u>part 3 of KCSIE</u> regarding safer recruitment and item 130 which explains that along with Academy, Free and Independent schools, a section 128 direction disqualifies a person from holding or continuing to hold office as a governor of a maintained school.

Schools Financial Value Standard (SFVS) – Maintained Schools – information

The <u>DfE have updated the dashboard</u> (and associated guidance) for the 2019/2020 SFVS to include additional RAG ratings for average teacher cost and spending on teaching staff as a percentage of total expenditure, to enable schools to benchmark different years of data.

Inspection Data Summary Report (IDSR) – Early Years to key Stage 4 – information

This DfE quide provides an overview of the IDSR along with information to help interpret the charts.

Copyright licences for state schools in England – information

The Department for Education (DfE) buys copyright licences for all state-funded primary and secondary schools in England which cover schools for almost all their copyright requirements. This updated guidance provides information on copyright licences and how copyright affects schools.

Pupil Premium – information

The government has announced that <u>pupil premium and service premium rates will increase</u> in line with inflation for the financial year 2020 to 2021 in April 2020.

Ofsted Updates

Ofsted are seeking views on the <u>removal of the exemption for outstanding schools</u>, colleges and other organisations delivering publicly funded education and training. The consultation closes at 5pm on 24 February 2020.

Ofsted Annual Report 2018/19: education, children's services and skills was published on 21 January 2020.

Key Stage 3, Making Decision in the Best Interests of Children, Judging the Curriculum

There has been speculation as to whether Ofsted has a fixed view regarding schools having a two-year key stage 3 (KS3). <u>Sean Harford HMI, National Director for Education, discusses</u> how Ofsted will be judging the curriculum and whether length of key stage 3 matters.

Governor Allowances Policy – Action Required

To support this <u>statutory requirement</u> LA Maintained schools, an updated Model Governor Allowances policy is available on GovernorHub (resources tab/previously on KELSI). We recommend in line with DfE, that this policy is reviewed annually.

Key Stage 2 - Assessment & Reporting Arrangements Guidance for 2020 – Action Required

Do you have arrangements in place to monitor this process and <u>ensure administration of the tests</u> is correctly carried out? Governing Bodies are encouraged to evidence good governance and best practice by ensuring monitoring visits during SATS week, to be followed up with a brief written report.

Free Training - Secondary Teacher Training Programme - Action Required

Secondary school Governors – is your school taking advantage of the free training that is now on offer to teachers in every secondary school to help foster a more positive attitude to PE?

Website compliance - your shop window to the world - Action Required

- When was the last time your Governing Board checked the school's website for compliance?
- How easy is it for parents or prospective parents to navigate your website?

Exclusions – Governor Training and Development - information

Our course 'Responsibilities of the Governing Body in Pupil Discipline' is being held in <u>Ashford</u> and <u>Tonbridge</u>. This course explores in-school early interventions to alleviate exclusions, the responsibilities of the Governing Body discipline Panel in reviewing pupil exclusions and best practice to ensure that the Governing Body is not left vulnerable.

NGA Learning Link module entitled 'Pupil Success & Wellbeing – Exclusions' has recently been reviewed and updated.

Schools Financial Risk Register – Action Required

KCC Audit department has highlighted that not all Maintained schools are aware of, including the need for the recording of, the financial risks that could affect them; <u>further information and a Schools Financial Risk Register template</u> can be found on Kelsi. The risk register is not required to be submitted to the Local Authority but may need to be seen as part of a compliance visit.

Health and Safety Compliance Statutory guidance Community and Voluntary Controlled schools – Action Required

To assist school Governing Bodies and Headteachers in understanding the statutory and legal requirements of health and safety statutory compliance within the school environment, the Health and Safety Statutory Compliance for KCC schools document defines the roles and responsibilities of duty holders, responsible persons and contractor management arrangements. The document is aimed solely at Community and Voluntary Controlled schools where KCC is recognised as the employer under the Health and Safety at Work Act 1974 and does not apply to any other school status.

GovernorHub - LA Maintained Schools - Statutory Compliance Action Required

All Maintained school Governors are required to register with GovernorHub; an email regarding access to the website, registration & password setting will have been sent to you by GovernorHub, your clerk and/or by whoever has assigned admin rights to the system, and can be re-sent if necessary. GovernorHub is:

- the Local Authority database portal, used for **statutory information** i.e. your contact details & email address
- used by Governor Services as the main gateway for communication and your access to resources
 A Full Governing Body Agenda Item Is Required Please ensure your Governing Body is compliant.

Schools' Personnel Service model - HR policies for schools' updates – Action Reminder

A number of <u>model polices were revised at the start of the academic year</u> including the SPS Redundancy/ Restructure and Capability.

All Kent Maintained Schools have free access to model policies; the Local Authority expects that all KCC Community and Voluntary Controlled Schools will use the model documents as the basis for their HR policies. The documents are also strongly recommended for consideration for adoption by Foundation and Aided Schools. Academies may wish to adopt these documents in their entirety or adapt these for use.

If you are uncertain what HR and other policies are required in your school setting please check the DfE Guidance Document 'Statutory Policies for Schools' <u>Statutory Policies for schools and academy trusts</u>
The SPS consultancy team are happy to provide support and guidance to Kent Schools regarding the adoption and implementation any HR policies. As part of a rolling programme policies are reviewed throughout the year. Please remember to check the SPS website regularly to ensure your school is working with the latest version.

Induction of Newly Qualified Teachers (NQTs) – information reminder

Academy and Maintained Boards' attention is drawn to the DfE <u>Statutory policies for schools and academy trusts</u>; you will find that an NQT policy is required to be in place; there is also the recommendation for a scheduled annual review. Information, guidance and a model policy from the <u>NQT Induction and Support</u> team can also be found on Kelsi.

LA Governor Vacancies - Action Reminder

For those Governing Boards with a Local Authority (LA) Governor vacancy, have you considered looking to your existing membership for the solution?

With the additional LA nomination guidelines to be considered (see nomination pack, GovernorHub resources), it can often be challenging to find the appropriate candidate/nominee to put forward for consideration by the

LA; could a governor from another category, such as co-opted or foundation, be considered for nomination to the LA category? If so, this could release a co-opted position to which the board could readily appoint whilst also resolving the LA Governor vacancy.

DfE funding has been awarded to <u>Inspiring Governance</u> and <u>Governors for Schools</u> (previously SGOSS) for governor recruitment activities and therefore it is important, if not essential, that you <u>register all your vacancies</u>, including the LA Governor vacancy, with both organisations.

A Reminder to Clerks – for the need to ensure that the minutes confirming the formal appointment of a Local Authority Governor by the Full Governing Body are sent by email to governorservices@theeducationpeople.org; should the case arise that the Full Governing Body decides not to appoint, the minutes should also be forwarded to Governor Services.
