Department for Education

Keeping Children Safe in Education (KCSIE)-consultation - Action Required

<u>Closing date - 21 April 2020</u> - The DfE are consulting on a wide variety of proposed changes to KCSIE statutory guidance. The aim is to help schools and colleges better understand what they are required to do by law and what DfE strongly advise they should do, in order to meet safeguarding responsibilities.

Discipline drive in schools - information

The Education Secretary (Gavin Williamson) announces a £10 million programme to curb unruly behaviour and prevent disruption in the classroom

Key Stage 1 SATs replacement - from September - information

From September 2020, all new primary school pupils will take the <u>Reception Baseline Assessment (RBA)</u> that will replace SATs in year 2. Following successful pilots all over the country, the RBA (a one-to-one exercise done in 20 minutes with a teacher in an informal setting) will be taken by all children in their first six weeks of primary school. The move paves the way for the removal of the national curriculum assessments at the end of key stage 1 from 2022/23 – commonly known as SATs – when pupils are aged six- or seven-years-old.

Pupil Premium - information

The Secretary of State for Education sets out the terms/conditions and funding allocations in relation to the <u>pupil premium grant (PPG)</u> payable to schools and local authorities for the financial year beginning 1 April 2020.

School Uniform Guidance - information

Currently non-statutory (but likely to become law/statutory), the <u>DfE's current school uniform guidance</u> strongly recommends important points for consideration by governing boards when setting a uniform policy - cost/best value for money from suppliers, being wary of single supplier contracts, discrimination law, requests to vary the policy to accommodate pupils' religion, ethnicity, gender and other protected characteristics. Does your board regularly review the school uniform policy? When was the policy last reviewed?

Secondary-Accountability Measures Guide - information (maintained, academies and free secondary schools) The current secondary school accountability system was introduced in 2016. <u>This February 2020 document</u> explains how secondary accountability measures are calculated and provides more information about announced policies that apply to accountability measures in 2019 and 2020.

Teaching Vacancies - (finance) - information

As the body responsible for ensuring the school's finances are managed effectively, ensure that any spending on recruitment advertising can be justified. This free job listing service is designed to help recruitment to teaching vacancies, ensuring money can be spent in the classroom.

Ofsted

Consultation - proposals to revise post-inspection arrangements - Action Required

Ofsted are seeking your views regarding proposals for revisions to post-inspection arrangements, **including how they handle complaints about their work**. The proposals, if agreed, will enhance Ofsted's current arrangements to deal with any queries or concerns about an inspection quickly and before an inspection report is finalised.

Making the cut: how schools respond when they are under financial pressure - information

This Ofsted research explores how schools make decisions when they are under financial pressure and what impact their decisions could have on quality of education. Headteachers in mainstream schools in England were asked to take part in an online survey; school leaders and other school staff were interviewed in order to explore - the main financial pressures that their schools were facing; how decisions were made in response to financial pressure; what decisions were made; the wider implications of the responses to financial pressure.

Academies - information reminder

<u>Moving MATs forward: the power of governance</u> is a comprehensive report by NGA which assesses the current context, oversight and practice of MAT governance; it provides recommendations for improvement to those governing MATs.

Creating the right dynamic: A guide to help governing boards work effectively as a team - information

This practical guide for NGA members is designed to support Governing Boards work effectively as a team. It refers to the factors that can affect the dynamics of a board and provides useful tips and strategies for building and maintaining relationships together with suggested approaches for creating an effective team dynamic.

Governing Board Panels - using outside individuals for panels - information

NGA has published a <u>Clerking Matters blog</u> on using individuals from outside the governing board for panels e.g. exclusions and school complaints. The blog (1 side of A4 only), discusses the steps boards can take to ensure that the sensitive issues which prompt panels can be managed internally; it also draws attention to the circumstances where the involvement of individuals from outside the governing board can be beneficial or even legally required; there is also practical advice on finding outside individuals who are suitable for joining panels and the process of formally agreeing their involvement.

Pupil Premium Guidance - information

NGA has updated its guidance for governing boards (accessible to NGA subscribers) to coincide with the recent DfE announcement which has been streamlined to make it easier to follow. It covers key aspects of the governing board's role - deciding how the pupil premium is spent; what goes into the pupil premium strategy; monitoring the impact and demonstrating accountability. NGA's Learning Link module also explores how governing boards fulfil their responsibilities relating to the pupil premium.



Governor Recruitment

NGA's 'Everyone on Board' campaign aims to increase the participation of people from ethnic minorities and young people in school governance. Please also consider the development needs of your senior and middle leaders, deputy, assistance and aspiring Headteachers in gaining valuable governance experience.

NGA believes that school and trust governance is almost always invisible when it's working well and very much in the spotlight when things go wrong.

On 28 February the Visible Governance in Schools campaign went live, it is to run throughout 2020.

NGA's intention is to achieve a higher profile and better understanding of governance and further improve the lives of children and their communities.

NGA suggests that school and trust governance must be more visible within the education sector and within society; they are delivering a year of celebrating the power of governance, the people that volunteer for the role and the value that good governance brings to the school system.

Education Endowment Fund (EEF) - Action Required

Clerks' Conference

We had a very successful clerks conference last month with the **Department of Education** as the keynote speaker asking for clerks' views on the **Role of the Clerk as the Governance Professional**, including the barriers and support to enable them to be the effective influencers to their governing boards.

There is currently key scrutiny by the DfE on the role of the clerk as the governance professional to inform future policy, legislation and guidance; we are delighted that Kent clerks may have an influence on any change. One of the key messages was for the need for the clerk position to be seen to be objective and serving the governing board with no possible conflict by also being a member of the school staff.

The Finance, Positive Influencer and Academy Clerking workshops all received very positive feedback. Below are some answers from the frequent questions asked during the conference:

- LA Governor Nominations information
 - Since the introduction of the updated streamlined process in September 2019, existing LA governors (those seeking a further term of office) will no longer be contacted as the end of the term of office approaches; it will be the responsibility of the clerk and the chair, together with the governing body, to pay close attention to governor vacancies and terms of office. The LA Governor Nomination Pack (2019) can be found at the resources tab on GovernorHub please familiarise yourself with this revised, more frequent and more efficient process.
- School Governance Updates Action Reminder
 - Regular updates from DfE are available for both <u>LA Maintained schools</u> and <u>Academy Trusts</u>, please be sure to <u>register for updates</u> directly to your email inbox; items in this edition include consultation on the removal of the outstanding exemption, NFER/DfE survey, GIAS national database requirements, compare how much your school is spending on agency supply teachers, clerks' voices required re the governance professional role.
- Keeping Children Safe in Education 2019 (KCSIE) Section 128 checks for governors Action Reminder
 Your attention is drawn to part 3 of KCSIE regarding safer recruitment and item 130 which explains that
 along with academy, free and independent schools, a section 128 direction disqualifies a person from
 holding or continuing to hold office as a governor of a maintained school.
- Succession Planning information

NGA has a <u>Learning Link</u> module to help governing boards understand the importance of succession planning and how to go about it effectively to ensure that there is continuity within the board, the right people in the right place at the right time, planning for the appointment of a new chair (and vice chair) – not a last-minute decision, but someone who wants, or is the best person for, the role(s). Modules on Safeguarding, Ofsted and the Arts and Cultural Education module have been updated.

Exclusions - Governor Training and Development - Training Reminder

LA Governors - Reminder for Clerks ...

Ensure that the minutes confirming the formal appointment of a Local Authority Governor by the full governing body are sent by email to governorservices@theeducationpeople.org; should the case arise that the full governing body decides not to appoint, the minutes should also be forwarded to Governor Services.

- Has your GB submitted a nomination in the last 6 months?
- Has the appointment been formally made by the full governing body?
- Have the full governing body minutes been sent to Governor Services?

Schools Financial Risk Register - Reminder

KCC Audit department has highlighted that not all maintained schools are aware of, including the need for the recording of, the financial risks that could affect them; <u>further information and a Schools Financial Risk Register template</u> can be found on Kelsi. The risk register is not required to be submitted to the Local Authority but may need to be seen as part of a compliance visit.

Schools' Personnel Service model - HR policies for schools' updates - Reminder

A number of <u>model polices were revised at the start of the academic year</u> including the SPS Redundancy/ Restructure and Capability; policies are reviewed throughout the year.
