The Holiday Activities and Food (HAF) Programme in Kent provides healthy, nutritious food and exciting, enriching activities for children and young people during the school holidays.

Families of children aged 4 to 16 years, who are eligible for benefits related to Free School Meals, can access these opportunities in the Easter, summer and Christmas holidays for free.

The HAF Programme aims to support the physical and mental health and wellbeing of children and young people in Kent, encouraging them to engage in interactive and fun activities and provide them with access to nutritious food.

This programme is funded by the Department for Education (DfE) to provide support for eligible families in Kent to access these holiday activities for free.

**The programme runs for a minimum of 4 hours a day, for 4 days a week. Each programme will run at different times and may have different ways of delivering the activities, but every HAF Programme is free for eligible children and their families to attend.**

- 1) Please find out more about the Bewl Water Outdoor Centre offer via the link above or letter from school.
- 2) Call us on 03000 415200 to check your child's eligibility for the programme. Please note, you will need to supply proof of a Kent address and eligibility for Free School Meals (such as Universal Credit award letter).
- 3) Once eligibility has been confirmed, talk to our team to confirm the dates you would like your child to attend our sessions at Bewl Water Outdoor Centre.
- 4) Complete the booking form overleaf and return to the address or email address above.
- 5) Upon receipt of your booking form, we will send out joining instructions to provide more specific information concerning the programme.
