3. Briefing and Networking Sessions March 2024

South feedback - Lisa/Penny

Recruitment and retention really worrying, ratios, still not recognised as educators 'just' childcare, funding rates may not be meeting what is needed, places may not meeting the needs of the new working entitlement

Attended different roadshow that the DfE has hosted, continuing to voice their concerns, including writing to MPs

Funding rates took too long to be published no time to plan ahead.

Influx of 2 year olds either FF2 or working parents

North feedback - Tracey

Here are the notes on the discussions/comments that took place in the breakout room at the Network meeting on Tuesday, 12.03.24 North meeting:

"Earlier info on funding rates not last minute – there were comments about other LA's having issued their funding rates way before Kent. I did mention that the reason behind it being so late was explained in emails from TEP. Some didn't recall seeing those.

Leading on from the above, a request for the Provider Association to ask KCC to push the DfE for funding rates to be given earlier.

One setting had applied to KCC recently for a grant to expand her setting and the process was complex and lengthy and if she hadn't had the support of an accountant friend, she would've given up applying as the questions/info required was way beyond her understanding and knowledge of the business as a Manager. Her view was that if KCC is offering grants (as mentioned in the Network Meeting) the process needs to be simplified or there needs to be more support available".

West/South feedback- Julie Miles

People were quite low Funding rate published so late PVI calendar not available as yet (at the time) Recording B&Ns would be useful as not everyone can attend (Action Alex and Lucy)

OOS/CM feedback - Denise

Wraparound discussion around funding, it was confirmed that it is not funded but has to be paid for by parents

Hard copy of the Provider Agreement would be useful.

Training or information on the new funding would also be useful.

Lots of changing that is happening all at once and people are feeling overwhelmed Change is difficult

Discussion: It was suggested that three questions are posed so it gives the discussion a focus- **Agreed**. Members are to email to agree these questions that the PA Reps will pose at the next round of B&N – Action all provider reps as per email sent

4. DfE New Free Entitlements and Wraparound Provision- DH &AG

Slides shared and an overview given of where we are currently, DfE estimate of demand for places for September 2024 and September 2025 and wraparound childcare - gaps in provision and modelled demand by district.

Denise Howard commented schools are willing to help with staffing - this has never happened before.

5. KCC Early Years Review – update Consultation closes on the 5 May - AG

138 responses have been received so far from providers and parents, which is very disappointing.
